REASON AND PURPOSE

Compass Executives were engaged in the services of Hengrui Therapeutics to source a Vice President – Biological Drug Discovery to head-up the European Research Centre in Switzerland; focussing on new innovations in protein engineering and multi-specific antibody research.

OUTCOME

An international research-based search was conducted with in excess of 150 suitable candidates targeted throughout the EU. A three stage interview process was completed including validation by the Senior Management Team based in both Shanghai and New Jersey, resulting in the first time appointment within 5 weeks of the process commencing.




